Hello Fellow Race Fans –

TC Race Committee – Our first 2011 TC Race Committee meeting was held Tuesday, February 22nd at Holman's. A meeting review was previously distributed and is available for discussion. The next TC Race Committee meeting will be held 7pm Wednesday, March 23, 2011 at Buster's BBQ (99W in Tigard). We need to discuss race event publicity, ROD Worker promotions and Sponsorship for equipment purchases.

- Trophies, checkered flags and event decals are being ordered.
- GV City Administrator and GV Fire officials have been contacted.
- ORP event request worksheet will be submitted to include toilets, ALS (2) and security hours.

Announcement/Supps/Schedule – These will be submitted prior to 3/30/11 for publication in ICSCC Memo, TC TellTale, posting to Facebook and other available media resources.

ICSCC RATS Meeting – This annual meeting was held Saturday, Feb. 26th in Auburn, WA. TC attendees included: Bob S, Russ N (TC ROD Rep), Linda B (TC Registrar), Karen M (ICSCC License Registrar), Michael Conatore (ICSCC Asst Steward), Adam & Rob J (ROD) and Peter L (TC Webmaster). ICSCC Steward Tom Olsson introduced Bill Skibbe (MyLaps, Orbits advisor), ICSCC Assistant Stewards Michael Conatore and Jon Bonforte. The following topics were covered:

- Re-iterated that all reports are utilized with review and follow-up;
- Stressed the importance of safe re-entry to course, don't want drivers to go evasive;
- Requirement for HANS device was voted down, will continue to focus on its importance;
- Need to stay consistent with published event schedule, no variance from rule book;
- At track injuries – involve the ICSCC Steward immediately for insurance paperwork;
- Tech/Express Tech should ensure driver gear is presented and checked appropriately;
- Race Chairman should have ICSCC certificate of insurance in hand at each event;
- Race Chairman, ICSCC Stewards, F&C and Base Comm to meet ½ hr prior to 1st worker mtg;

ICSCC License Registrar presented review of car number requirement (308A) and penalty for using wrong car number and/or transponder. Enforcement process begins at Registration. T&S can contact Registration to confirm correct information. Legibility can be confirmed at Pregrid.

Breakout sessions included ROD reps, Registration (Orbits), and MotorsportReg (Webmaster). Race Chairmen discussed recommendation to add ICSCC Asst Steward for Tech & Scales.
