## Picnic Directions

- From I-5 or I-205 take I-84 Eastbound towards The Dalles
- On I-84 take the 181st Avenue Exit, and turn south (right from the eastbound lanes)
- Continue south on SE 181st Ave, which makes a jog and becomes 182nd Avenue
- When you cross Powell Blvd (approx. 3.6 miles south of I-84) continue southbound
- (From Powell Blvd the road name changes from SE 182nd to SW Highland Dr. going up the hill, then changes again to SW Pleasant View Dr, and then to SE 190th)
- At the first stop sign on SE 190th (approx. 1.5 miles after crossing SE Powell Blvd), turn left onto SE Butler Road (on the right side of 190th will be SE Giese Rd)
- Go to the stop sign and turn right (Butler Creek School will be directly in front of you at the stop sign)
- Follow Butler Road through a 90 degree turn to the left, continue on Butler about 100 yards past a new development and we're the tan house on the right (2212 SW Butler Road). U-sharped driveway and a white sign at the 2nd driveway says Butler Big Oak Century Farm (by the Large Oak Tree). If you go down the hill, turn around and come back to the first driveway.
