**Driving Master**, Dylan Olsen: Driver's Training was successful. We did not generate as much income as we had hoped but we had a great time. We had a \$1000.00 loss but overall for the year we made about \$2000.00 from Driver's Training. We had six students with the remaining participants in the HPDE and Test and Tune. Biggest factor for our loss is due to the high track fees this time of the year. Skip pointed out that maybe we should try for two early season events when track rental is less expensive. Stacey thanked Darcy for the work in Driver's Training and Darcy thanked Stacey for her work as Assistant DT Registrar.

**Treasurer**, Stacey Smith: Recap –DT loss is \$1000.93, race will be about \$800.00. Total loss for event will be approximately \$1800.00.
