## TC Supplemental Regulations 2017



- Move in to the paddock at ORP will be available upon completion of Registration. The process of moving in/out of the paddock may take extra time. Please be patient and courteous - Thank You In Advance For Your Support ! Main Gates will open Thursday 6pm and will remain open 24hrs per day until Sunday at 6pm. Friday entry and paddocking will only be allowed as directed by the paddock marshal. Arrivals before 6pm on Friday are asked to line up starting at the area just south of Pregrid. DO NOT BLOCK THE ENTRY ROAD. Please line up drivers left on the road. Paddocking will start as directed by paddock marshal as soon as possible during Friday's event.
- 2. Online paddock reservation tool does not guarantee placement, only preference. TC reserves the right to adjust your paddock location.
- 3. Any Driver, crew, spectator, transport driver, or attendee displaying unsportsmanlike, vulgar, or aggressive conduct toward TC, ICSCC, or ORP staff, will be dismissed from ORP along with the team for the weekend by the direction of either the race chairman, ICSCC steward or both. <u>Unsportsmanlike, aggressive</u>, and vulgar personal conduct directed at any race staff will not be tolerated during the race weekend. See supplemental regulation 11.
- 4. Registration & Express Tech will be held at ORP Administration Building near Pregrid;
- 5. Friday race registration hours 7:30am 8:00pm. After hours registration available with prior arrangements.
- Express Tech is available at Registration for those drivers who meet the following: 6.1 Completed entry form(s). 6.2 Prepaid in full. 6.3 No license issues.
  6.4 Vehicle has a transponder and does not require a rental. 6.5 Have an acceptable Annual Vehicle Tech inspection sticker on their vehicle log book and a 2017 Annual Gear Tech sticker on the back of their competition license.
- 7. Family and Crew members with questions are to contact Driver Services at ORP Administration Building.
- 8. Due to extreme fire danger, smoking is permitted only on paved or gravel areas. Extinguish and remove smokeables carefully and completely.
- 9. Event announcements will be made on FM radio channel 100.1 and/or a PA system. Please be prepared.
- 10. This event is organized under 2017 ICSCC Competition Regulations and all who enter ORP are subject to them.
- 11. Team Continental reserves the right to refuse entry to this event or to ORP at any time.
- 12. Participants under 18 years old are not allowed in hot pits. Children under 12 require direct adult supervision at all times.
- 13. A current and properly completed minor release form, signed by an authorized adult, must be on record for all minor participants at ORP.
- 14. No skateboards or scooters allowed in the paddock area. Users of bicycles and small motorized vehicles may have riding privileges revoked at any time. Per ICSCC 1606. Motorized vehicles A. Motorized vehicles, including racing cars, shall not be driven in the pit or paddock areas by persons not having a valid state or provincial driver's license. Per ICSCC 1603. C. Children under twelve years of age may remain in the paddock area only under the direct, active and continuing supervision of an adult. No bicycles are allowed in the racing pit area except as they may be used by Race Officials. **Bicycles may be operated in the paddock area by persons 12 years of age and older.**
- 15. Refueling not allowed in Pregrid. Fueling in the hot pits requires a crew member assigned only to operate a fire extinguisher.
- 16. Pit and Pregrid roads must remain clear.
- 17. Pit lane speed limit is not to exceed 25 mph, pit lane speed zones will be marked with double cones at the entry and exit of pit lane.
- 18. Damage to ORP grounds, equipment or structures regardless of cause, will be charged to the driver responsible. Also, damage to any equipment or devices used by the sanctioning body (ICSCC) or sponsoring club (TC) to conduct this race, regardless of cause, will be charged to the driver responsible.
- 19. It is recommended you have access to a sealable container capable of holding 2 gallons of liquid. These are to be used to remove all oil, cleaners, brake fluid, etc. from ORP. There will be no drums provided.
- 20. If entries exceed the number of cars allowed on the track for a particular event, drivers and cars entered as an additional entry will be restricted from participating based on the date entries were received. This is in order to allow participation by all drivers for whom the event is their primary event, including Novices upgrading to a championship event.
- 21. NSF checks will be charged an additional \$50 fee.
- 22. Staggered start and split start requests shall be submitted to the Race Steward no later than the end of on-track activity on the day previous to the race.
- 23. Potable water, electricity and cell phone service may be limited or non-existent. Verizon wireless customers typically have coverage, but this is no guarantee of signal.
- 24. Pets must be leashed at all times and owners are responsible for cleaning up waste.
- 25. All in-car timing system transmitter beacons will be placed at a location designated by the Race Chairman.
- 26. Pit-out blend line violations will be dealt with by the Race Steward.
- 27. The 5-minute warning may be given earlier than 5 minutes before the scheduled session start. But not more than 9 minutes before the scheduled start.
- 28. All race vehicles towed from the track may be dropped off at impound.
- 29. Additional supplemental regulations may be included in your registration packet...Please be prepared.
- 30. Anyone entering the ORP property agrees to allow TC to disclose any information held by TC about yourself should an ICSCC incident report be required for damage or injury. TC will release any and all information, should it be required, to ICSCC, ORP, and or PMM LLC upon their request for insurance purposes only.
- 31. Novice drivers achieving their senior license upgrade on Saturday will be allowed to enter a Sunday race at no charge.

## Group H – Hare & Hound Pursuit

Overview:

The Hare & Hound pursuit is a special event, as defined by ICSCC PPM 23.2. There will be 3 on-track sessions totaling 80 minutes for the entry fee of \$150. Group H qualifying session will determine start times for each competitor.

Race length is scheduled for 30 minutes. Starting order will be inverted, with the slowest car starting first and fastest car starting last. Start times will be staggered such that closest competition among all cars will be at the checkered flag!

#### Prize Money will be presented to Top 5 Finishers!

**Regulations:** 


- 1. Entry to this race does not have to be in conjunction with any other race(s)of the weekend.
- 2. Special events shall comply with all ICSCC Competition Regulations for the current year.
- 3. Available to closed wheel cars eligible for ICSCC Group 1, 2, 4 or 5.
- 4. Cars must pass ICSCC Tech & Safety inspection.
- 5. Drivers must register using a license approved by ICSCC License Director.
- 6. To encourage the highest level of ethical competition, any driver that runs a race lap 3 seconds faster than their qualifying time will be disqualified.

Hey Club Members, Friends of Club Members and Race fans!

Team Continental is doing something proactive to encourage drivers new and old to attend our August Race. One of the many things Race Chair Bob Smethers has scheduled is a "Hare and Hound Race". If you have never seen one of these, they are always the most exciting races from a spectator point of view, largely because the winner is seldom determined until the last few seconds of the race.

The way it works is all cars are handicapped at the start by adjusting the release time so that the fastest car starts last (sometimes by more than a lap down). The slowest car starts first. Drivers establish a qualifying time in a previous race, practice or qualifying. The lead allowed to each car is calculated such that if every driver can run exactly his qualifying time for the duration of the race all cars would cross the finish line at the same time. To



discourage "sand bagging" any driver that runs a race a lap 3 seconds faster than their qualifying time is penalized. This is a race that rewards a very consistent driver rather than the fastest car.

I ran one of these events in Spokane a few years ago and had a blast driving the slowest car in the race. (I got badly spanked by 10 or 12 more consistent drivers, but with 15 seconds of not driving sideways I would have won)!

This format offers truly "spectatorable" racing, and that makes it prize worthy!

To that end, (and to give more people a reason to make the trip to O.R.P. for the weekend) Star Projects will be generating a prize fund and soliciting individual donations of \$100 to fund a \$1,000 minimum purse. If \$1,000 is good \$3,000 would be better. Larger contributions are welcomed and Team Continental will give Hare & Hound race naming rights to the top contributor.

If you or your business can donate to this prize fund it will help us draw more competitors to the weekend and help Team Continental meet the regular costs of the event. If we can generate local interest in "The Spectacle of Motor Racing" it only helps further our sport.

• Continue south on SE 181<sup>st</sup> Ave, which makes a jog and becomes 182<sup>nd</sup> Avenue

When you cross Powell Blvd (approx. 3.6 miles south of I-84) continue southbound (From Powell Blvd the road name changes from SE 182nd to SW Highland Dr. going up the hill, then changes again to SW Pleasant View Dr, and then to SE 190<sup>th</sup>)

 At the first stop sign on SE 190<sup>th</sup> (approx. 1.5 miles after crossing SE Powell Blvd), turn left onto SE Butler Road (on the right side of 190th will be SE Giese Rd)

• Go to the stop sign and turn right (Butler Creek School will be directly in front of you at the stop sign)

Follow Butler Road through a 90 degree turn to the left, continue on Butler about 100 yards past a new development and we're the tan house on the right (2212 SW Butler Road). U-sharped driveway and a white sign at the 2nd driveway says Butler Big Oak Century Farm (by the Large Oak Tree). If you go down the hill, turn around and come
