

Call to Order - President Jim Larfield called the meeting to order at 7:00 PM

Reports from Board members:

President – Jim Larfield Thanks to Kevin Smith, our driver training made money. People had fun. It was fun to see it all come together and click for our students.

Driving Master – Kevin Smith We made money! We received \$750 over what was projected. We also had a total of 14 cancellations and several of those were going for conference licenses. Of the ones we did have, 5 were Novice Eligible.

Vice President – Joe Harlan No VP report, No Bylaws report

Secretary – Toni Larfield Absent, No Report. Stacey Smith taking notes in her absence.

Treasurer – Stacey Smith We have \$8460 in checking. The \$2000 I moved to make sure we could cover any checks we needed to write, has already been returned to the savings account. Financials show the breakdown of revenue and expenses for DT, with a profit of \$1744.85.

Contest Board - Jon Wilson No Report

E Board – Mike Conatore Absent, No Report

Communications Director – Tony Hauser No Report, Needs articles for Tell Tale by a week from Friday.

Race Chairman – Bob Smethers I have prepared a preliminary 2019 budget & event schedule suitable for review. These currently apply to a 2-day/2-race format with a Special Event. Extra sessions dedicated to the Special Event could consist of an ICSCC Affiliate Club or any other suitable marque club interested in partnering with TC. I am looking at the possibility of SOVREN or HPDE 3 20 minute sessions. We need 25 additional entries for a special group at \$400-450. Found that SOVREN also reimburses their workers so no savings there. Maybe they can reimburse their workers and we reimburse ours. SOVREN rules, issues, conflicts would have to be worked out. Need to look at other options – enduro, etc.

Committee Reports:

Picnic – Bob Smethers We tentatively have this years' picnic scheduled for Friday-Saturday, August 3-4, with a nice area in the trees reserved at Pat's Acres Racing Complex. Our facility rental cost is \$200 for both days. This amount could be significantly reduced or offset completely, depending on whether participants are interested in renting karts. Cost for rental includes Basic Membership (\$12) and Rental Kart – 9hp, 12-minute sessions, 50 mph (\$25).

Featured activities include extensive BS sessions starting Friday night with potluck meal. Salad & Desert contest on Saturday with prizes awarded. Saturday meal is forecast to include burgers & brats and may include a fabulous smoked meat.

This event could be a fabulous membership drive opportunity – spread the word & bring a friend!

One additional idea – TC could buy carts in a quantity large enough to offset the rental fee and raffle them off to general membership at the General Meeting to help get people to attend the meeting. The raffle would be free of charge!

Membership – Denny Roberts No Report

Membership Drive – Joe Harlan 3 PCC Grad students participated in the DT at ORP. They are also new members. Free membership deal worked out and didn't cost us anything. We need other race cars at PCC Graduation. They were very excited about it. Jim floated the idea of possibly offering a credit toward an event for working at another event. No free ride, set a max discount credit allowed per event. Bill willing to donate a car for a day.

New Business:

Driving Master – Kevin Smith Sept. 2018 DT Budget prelim. Suggested we try a new model. Set pricing and entries needed 35 days ahead, not enough entries at that time, then we cancel the event. If we have enough entries to go forward, at day 34 out from the event, we charge MSR and have no refund policy. Have to make sure conference will give insurance for event with 45 days notice but able to cancel 30 days out without being charged. Could do Saturday 22nd or Sunday 23rd of Sept. 2018. Board poll preferred 22nd.

Vote – Motion to reserve Sept. 22nd, 2018 at ORP Jim Larfield, second Joe Harlan. Approved unanimously. Start advertising in May as soon as the flyer is ready and conference has been contacted. May do an abbreviated school – Instructors in cars, no ground school.

Memories are important, and with Alzheimer's disease, they ebb and flow as time erases the essence of a lifetime. The insidious trick is that the victim can have periods of high retrieval only to slip back into an abyss of grasping for a thought that won't come. This night Bob was hav-



ing an evening of lucidity and we talked for 20 minutes without any of the fog that sometimes drifts into such conversations. One thing was clear to me, He was very grateful for the call.
