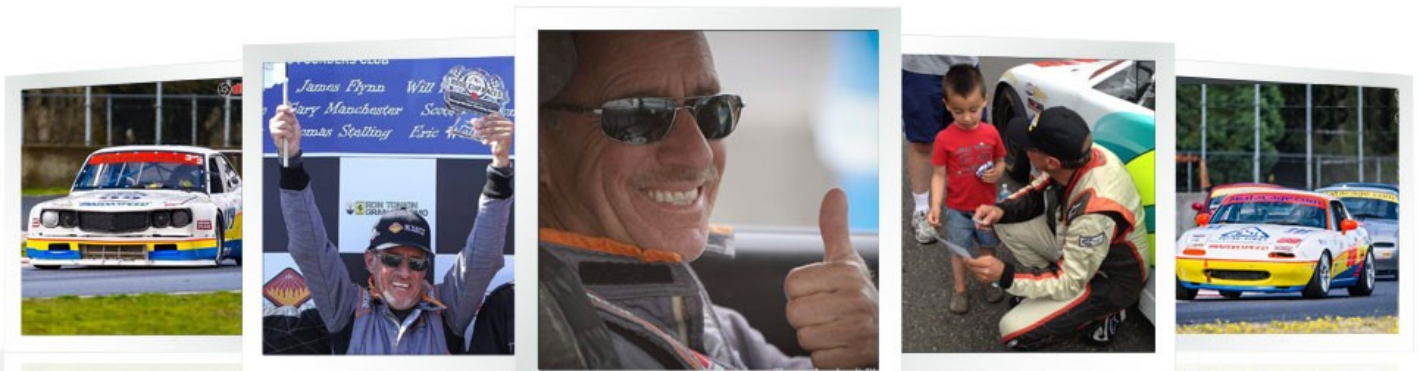

Steve Leonard entertained a discussion for Team Continental's future direction to increase membership and club revenue from our new Track Time Trials. The general meeting consensus was to continue holding driver's training and TTT events at ORP for 2020.

Joe Harlan reported on the successes of the driver's training and Track Time Trial events at ORP. Joe informed and educated members on the advertising, technical, and mechanical operational aspects of the TTT events and how well they have successfully performed for the club.

Joe shared the new outside interest numbers in the TC club events. Joe has had about 150 people interested in the TTT events. He provided TC facebook page interest of between 8 and 15k hits a month. The Buzz is getting around and the TC club made a big investment in 2019 to get the events started and operational at ORP.

Joe announced a new concept that could be good for TC and Conference racing would be to attract people to a new entry-level program. It would start with the possibility of expanding the boundaries for hosting TTT events. We might be able to get the interest of other clubs to hold an event at other tracks and to create a TTT event series at 4 other tracks. The overall outcome would grow membership in Team Continental and Conference. Joe indicated that he got a decent reception and interest from two of the other clubs and the current Conference President. Joe feels that, with this new concept, TC could take the lead on who grows club racing membership and Conference racing events in the northwest. Conference currently has only 300 licensed race

drivers. Joe indicated times are tough for everybody in the racing communities and we need to identify the “really cool” programs that are helping us the most.

Duane Starr mentioned he is willing to be our Membership and Track Event TC ambassador for Central Oregon.

Bill Murray elaborated on the concept of customer retention and TC membership recruitment opportunities. He would like to see the TC picnic be more related to a club driving event and have a nice picnic afterwards to celebrate the day.

Bill Murray quoted the great sage and wise man, Jon Wilson, who once said “The reason we race cars is so we have something to talk about when we sit around and drink beer.” I could not agree more. Thanks Jon for your legendary TC quotes!

President’s Closing Message: “Anything that gives the club a shot to continue into the future and builds new members is good for the club.”

Steve would like to see the possibility of a chapter of TC to start in Central Oregon with people who would like to be a part of a racing organization and host events rather than just being customers of our club. Duane Starr and Steve Leonard have had discussions about the possibility of expanding Team Continental into Central Oregon. Further discussions will be continued at the board meeting. Stay tuned for any new updates and developments as they become available. Discussion was entertained to partner with other clubs in Central Oregon and Washington Tri-Cities.

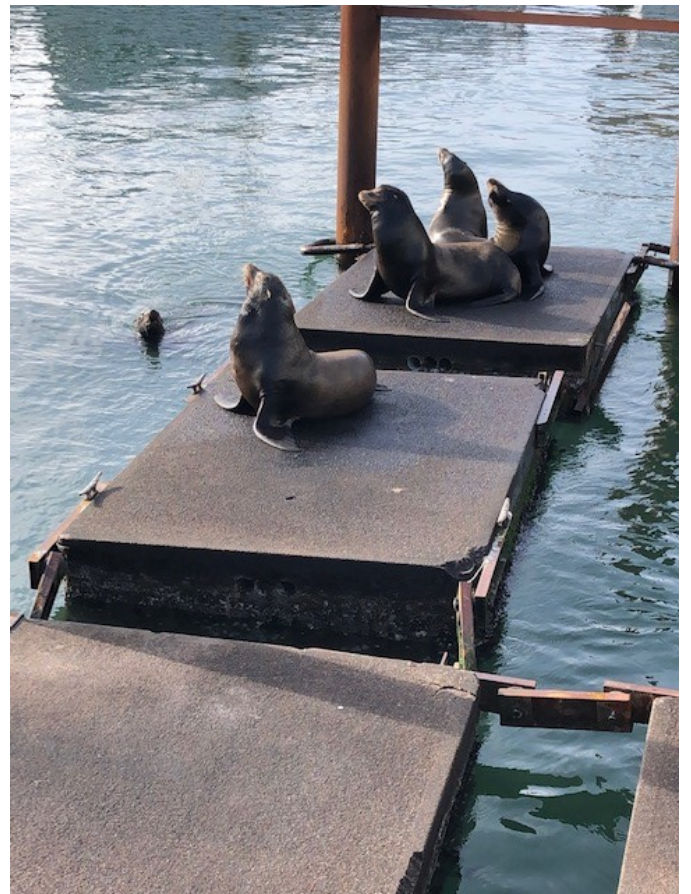

ANNOUNCEMENTS: Meeting was called to order at 7:00 pm by TC President Steve Leonard;

ATTENDANCE: Steve Leonard, Bob Smethers, Don Smethers, Sonjia Smethers, Jim Larfield, Steve Adams, Joe Harlan

OFFICER REPORTS:

PRESIDENT (Steve Leonard):

Steve wanted to say he joined TEAM CONTINENTAL because it was a racing club.

Steve wanted to have open discussion for proposed location to have our board meetings and our general meeting.

VICE PRESIDENT (Bill Murray): No Report.

SECRETARY (Steve Adams): Board Meetings will be recorded and submitted in a general written report format to fulfill the TC Board Meeting Minutes. The January General Meeting Minutes were submitted to Tony Hauser and will be published in the Tell Tale.

TREASURER (Don Smethers): Submitted Team Continental 2020 January Financial Report. Report is on file and available upon request.

Taxes have been signed and submitted.

This year's Team Continental Banquet was not subsidized by the club and was made possible by Sonjia's good negotiating skills for a better dinner entree selection and overall banquet cost for the club event. Thank you, Sonjia! The Banquet cost came to \$3,200.00

The CD that we started 10 months ago on 4-1-19 has earned \$1,036.08.

A payment of \$2,500 from ICSCC Race Promotion has been deposited in the TC account.

We discussed leaving Jim, Joe, and Don as the TC account signers at this time. No need for any changes currently. Motion was brought up and all were in favor. Motion passed.

DRIVING MASTER (Lynn Coupland): Absent, no report.

EXECUTIVE BOARD REP (Joe Harlan): Canadian race clubs are going to provide their own CASC insurance this year. SCCBC is going to provide \$450.00 to \$500.00 dollars to the Conference race pool fund. SCCBC is going to hold one Conference race for 2020.

The race licensing and physical requirements are still on hold.

Cascade is lobbying very hard for an enduro license that wouldn't require standard physicals and licensing. Cascade is trying to compete with the Lucky Dog Racing events?

Conference race forms are now posted on the website and the medical form is still the same.

Lucky Dog does not provide participant insurance for the drivers or workers. So, you need to provide your own medical insurance for their race events. That's how they get away with the lower level of insurance that they are paying for their race events.

Joe indicated that we have lower interest in conference racing due to reduced driver's training events. Joe proposed a new idea at the Conference Board Meeting that we take TC's new time trials program on the road to other race tracks, like Pacific, The Ridge, PIR, and have the final time trial event at ORP to finish out the season. Joe indicated he didn't get a hard no from any of the other board members.

Joe recommended we give up trying to hold a race at ORP but continue lobbying to hold driver's training and, possibly, our new TTT events at PIR. This would be a great opportunity for TC, as well as Conference, to get exposure and increase racing opportunities in the NW.

Joe indicated that trying to combine a time trial event with a race weekend event would not work due to limited track time. It was outlined that it takes approximately 15 to 20 "club volunteers" to put on a time trial event at ORP and other tracks alike.

Joe was approached by Northwest Region about renting radios for The Ridge race. Their normal rental radio supplier is going to Spokane for an event that weekend (first weekend in June). They would like to rent TC's radios to support their SCCA race event at The Ridge. Joe would request we get honorable mention for supporting the race communications that SCCA race weekend.

TC has approximately 40 to 48 radios to support the communications of the proposed SCCA race at The Ridge race event. We would have a cost and rental agreement terms to protect our TC radio equipment during the rental use. We would need to investigate a radio base station.

Steve Leonard requested Rick Farrar investigate the cost and rental agreement. Joe was appointed by President Steve Leonard to contact Northwest Region and Oregon Region and see what equipment they need and date they would require delivery of the radio equipment. Joe is to report back to President Steve Leonard and Steve will administrate the remaining rental terms and agreements for the TC radio equipment.

Bill Murray requested the radios be moved from ORP to Portland so we can verify the operation before we commit to renting them out.

TRACK EVENT CHAIR (Jim Larfield): We are open on Motorsportreg.com for entries to our ORP time trial event. We have our new ORP March driver's training and TTT event website online and we have received 5 entries at this time. Jim will be recruiting volunteers to help and fulfill track operations positions for the event.

Jim has been investigating trophies for the ORP Track Time Trial event. We spent \$10.00 for the trophies at our last TTT. We used an online company called Crown Awards as the vendor.

Bill Harris would donate money in the amount of \$500.00 to the ORP TTT for an after-event dinner and awards banquet. Joe would approach Peggy for another donation.

We need to make sure we have enough bottled water for the participants and volunteers.

Jim is requesting volunteers for the drivers training and chalk talk instruction. Jim is going to do one session and Joe will do another session.

Steve Leonard requested we place an ad in central Oregon to advertise our events at ORP. Steve volunteered to write the ad and submit it for publication. We would need pictures of race cars on track to place in the ad.

Jim proposed a time trial event to follow the Auto Cross of Central Oregon event. Jim would like to offer the ACCO members a time trial event the next day at a proposed 15% entry fee discount. They have their event at ORP the Saturday in April the day before our Sunday TTT event. A motion was made and unanimously approved for Jim to offer the discount.

COMMUNICATIONS DIRECTOR (Bob Smethers):

Proposed marketing budget for 2020 is \$999.15 rounded up to \$1000.00 for 12 months. This covers TC domain name web page fee for 12 months, TC Tell Tale supplies and postage fees, publicity, and marketing costs needed for facebook to advertise our Track Time Trial events at ORP. Motion was brought up to approve the marketing budget for \$1000.00 and all were in favor; motion passed.

Bob reported that TC was approached in a mailing proposal "Talk 360" to publicize our club with a marketing package for a fee of \$3500.00. Bob recommended we decline the offer and move no further on it. All board members were in favor to decline the offer. Motion passed to decline offer.

Bob has sent our TC Club announcement, schedule, and subs to ICSCC Headquarters that Jim has approved for the Time Trial Events.
