For years (long before 1986 when I got thrown out of my 1st driver's training at PIR) TC would hold 4 ICSCC sanctioned driver's schools a year at PIR. This changed in the late 2000's. These driver's schools were the primary source of income for our Club. After years of doing these schools, those earnings afforded TC the ability to host and operate a Team Continental race weekend of our own! Epic racing and equally epic partying ensued.

These driver training events are a big opportunity for Team Continental to bring new drivers into the sport and grow our membership and increase the driver count in ICSCC races. More cars, and more drivers makes better racing.

I personally am overjoyed to share this very special news with each of you.

Also on the good news front is an offer from Cascade for TC to co-host their 2022 August PIR race.

This is a generous offer and here's why:

To post the weight of your Race car just write the “weight” lb. of your race car on a piece tape to the window for the Race Officials to view.

>We only have 14 license Conference Driving Members currently.

>We haven’t put on Race in 5 years, and that was mentioned in the E board meeting.

> 2 clubs brought it up in the meeting. One of the clubs suggested would TC consider becoming an affiliate club? Joe said we would consider it. If Conference was going to throw as off. Joe commented back just be aware if Conference does that we will be eligible to have a race at any track in Conference. Conference was not interested in making TC an affiliate club. Conference Board is only interested in keeping the 5 clubs as is moving forward.

>Spokane Racetrack appears to have new life in it with the local Indian tribe purchasing the track and interested in developing the racetrack events.

>Race Tech. Car weight is now agreed to be posted in the window of the race car near the cockpit area to help race officials quickly identify the car weight.

>Joe announced that he is now on the Conference ICSCC audit committee and will be reviewing the books.

>Dave Bennitt has recommitted to be the Conference ICSCC Insurance coordinator for 2022.

>Joe announced their will be a new Race Steward for 2022, Brad Greco.

>Conference is financially stable currently and has a has a budget overage and is waiting for a pending cost to assess the final operating budget for 2022 Race Season.

>Steve Leonard commented on how diplomatic Joe was in the E board meetings. Room applause was given to thank Joe for his TC club representation.

>Joe noted if TC Club continues the path of holding time trial events, we would be forecasted to recruit drivers into Conference Racing in the future. Our TT events are steppingstones for new drivers in to competing in Conference racing events that will grow Conference Racing.

>ICSCC Board Member raised the question if TC Race Club would consider being an Affiliate, Member Race Club?

>ICSCC Board Member spoke up, "that we need to maintain a five-club membership and not make any changes at this time".

>Joe replied in the E Board meeting that TC Race Club is the only entry level program that is promoting racing for ICSCC to groom up a new program for entry level racing.

Joe proposed a TC Club Driving Training School, HPDE and Time Trial at PIR and to incorporate a turn worker training day as part of that. Conference ICSCC was fine with Joe's proposal because he had secured permission in

advance of the E Board meeting. Joe indicated he did not have a proposed PIR event date to give the E Board at that time, but TC Race Club would be proposing a date soon.

>Joe announced that he signed up to Audit the ICSCC Conference books for the 2021 year. Joe has not been contacted on how to be a part of that review committee yet.

>Joe volunteer for re-writing a rule change for Novices Racers and how much work they had to do to get a ICSCC Competition License, but it was motioned dead in the meeting.

>Jim Larfield pointed out that Conference ICSCC license driver has decreased on average of 10 drivers per year to current 261 License Competition Drivers. Conference ICSCC need to do a better job of promoting new Novice and License Competition Drivers to race in Conference ICSCC events.

>Joe pointed out for ICSCC clubs to put on a race event and make money or break even we need to combine it with a Time Trial Event, HPDE or Enduro.

>Joe indicated that there is a big faction of people in the northwest that are trying to bind these race organization and events together to share in the overall costs of a racing event to reduce the racing event expenses so these clubs can make money.

>Joe indicated he would like to find a way to incorporate our TC Time Trial into a Northwest Region Race Event in the future.

>Joe announced that SCCA Northwest Region had a 18% increase in License Drivers in the past year, this is a good trend.

>Joe pointed out the incentive that SCCA is using currently, when you pay a entry fee for a SCCA Race Event they comp your first-year competition license fee if you have not been racing in the last three years. This is a good incentive to increase race entries and drivers back to Motor Sports Racing.
